I hereby grant the arbitration committee full power to check my animals in any manner they deem necessary and if in the opinion of the arbitration committee, my animals are judged to be artificially tinted or altered, I understand I will be barred permanently from MCBA sanctioned shows and my membership will be canceled and my animals will be disqualified.
